

Job Description – Lead Teacher, Dysart School

Main Pay Scale / Upper Pay Scale

SEN Allowance

(Upper limit is payable following the acquisition of a post-graduate qualification in the field (supported by the school), or the completion of two years in post at Dysart)

General responsibilities:

- (1) The education and welfare of designated classes or groups of pupils in accordance with the requirements of Conditions of Employment of School Teachers, having due regard to the school's aims, objectives and schemes of work, and school policies.
- (2) To share in the corporate responsibility for the wellbeing and pastoral care of all pupils.
- (3) To carry out any reasonable instructions given by the Principal or Senior Leadership Team.

Specific Duties

1) Leadership and Management

- a) Promote best practice in inclusion across the school.
- b) Lead and support the staff team for the satellite provision (SP).
- c) Work as a member of the wider school team, planning co-operatively, sharing information, ideas and expertise.
- d) Consult and plan with multi-agency colleagues.
- e) Establish and promote good relationships with parents and carers to improve pupils' learning and development ensuring co-productive approaches.
- f) Effectively deploy staff working in the SP to support pupil progress and promote independence.
- g) Working with the Principal to ensure that access arrangements for national tests and examinations are in place for pupils who can access them.
- h) Ensure that access arrangements to mainstream integration opportunities are in place where appropriate.
- i) Provide performance management for SP staff in line with school policy.
- j) Alongside your appraiser analyse a variety of progress and attainment data to inform priorities and self-evaluation.
- k) Work closely with senior leaders regarding inclusive policies and practices.
- l) Contribute to policy writing as required.
- m) Work closely with the school's Leadership team, governors and staff from OHCAT.
- n) Maintain confidentiality with regard to information gained in the course of professional duties.

- o) Work closely with the Principal and assistant Principal to coordinate admissions to the provision including responding to requests from the SEN team.

2) Management of Learning, Teaching and Resources

- a. Have clear intentions for children's learning and to use knowledge of school policy and National Curriculum requirements to plan differentiated work to meet the needs of individuals and groups promoting progression, continuity and quality of learning.
- b. Use a variety of suitable teaching and learning styles and to communicate clear learning objectives and expectations.
- c. Use relevant classroom management strategies to ensure that a purposeful environment for teaching and learning can take place.
- d. Organise and maintain a stimulating working environment appropriate for the range of activities taking place.
- e. Ensure that resources are organised and readily available to promote learning.

3) Management of People and Pupils

- a. Support behaviour taking into account the MHWB needs of pupils.
- b. Establish and maintain a positive regard towards both pupils and staff.
- c. Work as a member of a team, planning co-operatively, sharing information, ideas and expertise.
- d. Consult and plan with multi-agency colleagues, as appropriate.
- e. Establish good relationships with parents and carers to promote pupils' learning and development.

4) Evaluation and Quality

- a. Consistently and accurately assess pupils' **attainment** in English, maths and science
- b. Monitor and assess pupils' work and use assessment data effectively to inform planning and identify individual needs. Use these assessments to set appropriate targets.
- c. Keep effective and in-depth records of pupil progress and report overall **achievement** in lines with school policy and statutory requirements
- d. Write the report for Annual Review and provide high quality video/photo evidence to present at review.
- e. Gather evidence of work for the purposes of moderation.

5) Management and administration

- a. Attend and lead assemblies as required.
- b. Register pupils at the beginning of the morning and afternoon sessions.

- c. Supervise pupils in the playground and at lunch according to the rota.
- d. Attend weekly staff meetings.

6) Professional development

- a. Attend school based in-service training.
- b. Deliver in-service training to colleagues as appropriate.
- c. Take an active part in identifying and working on one's own professional development needs.

7) Whole-school responsibilities

- a. To contribute to the school improvement planning and school self evaluation process as appropriate
- b. To be an active member of the teaching team, supporting and at times leading on new initiatives.
- c. Participate in the performance management process agreed in school, in line with national guidelines.
- d. To play a full and active part in the life of the school.
